Best Practice	Micro-Business Grants for the migrant population in Guyana
Description	The initiative known as the Micro-Business Grants for the migrant population on Guyana focused on securing employment or self- employment to allow migrants and their families to generate income, while supporting the financial security within their communities and generating income opportunities for their members.
Objective	Provide financial support to staring, reopening, or expanding small businesses, revitalizing the economy at the community level, and creating and recovering employment opportunities.
Location	Guyana
Beneficiaries	Venezuelan migrants living in Guyana

INTRODUCTION

The following Best Practice (BP) was developed by the International Organization for Migration (IOM) in Guyana.

The initiative began as a pilot project and will be called henceforth Support Program for Entrepreneurship (SPE); it is part of the Regional Action Plan to Strengthen Response to Venezuelan Outflows¹ in order to support the Governments that hosted Venezuelan nationals and to respond to the needs and priorities expressed by Governments and migrants, such as: complementing existing national and regional coordination mechanisms supported by the IOM's Migration Emergency Funding Mechanism (MEFM)².

The actions of the initiative Support Program for Entrepreneurship (SPE) contributed to the achievement of the Sustainable

Development Goals of the 2030 Agenda, especially focused on the Target 8.5. which makes emphasis in the importance of "achieve full and productive employment and decent work for all women and men, including for young people and persons with disabilities, and equal pay for work of equal value". Regarding the Global Compact for Migration, the strategy contributes to goal 6, which seeks to "Facilitate fair and ethical recruitment and safeguard conditions that ensure decent work".

The documentation of this experience was made possible thanks to the support of Monserrat Hernández from the IOM Guyana office.

CONTEXT

The Latin American and Caribbean region has faced in recent years a context with unprecedented refugees and migrants whose impact extends to much of the hemisphere. By 2020, it has been projected an increase in Venezuelan migrants worldwide of 6.5 million, and in October 2019 reached 4.5 million, almost 85% would be located in the Latin American region (Data from the Coordination Platform for Refugees and Migrants from Venezuela)³.

The concern of States began to increase as the growing number of migrants in vulnerable situations that risked exploitation and abuse⁴ increased with these massive flows; specially gender-based violence⁵

and family separation leading to situations of unaccompanied minors or separated from their families⁶.

The Regional Action Plan to Strengthen Response to Venezuelan Outflows was presented in 2019, as a response to the migratory crisis⁷ that occurred as a result of the socio-economic policies and human rights situation in the Bolivarian Republic of Venezuela.

The countries of Latin America and the Caribbean have shown continuous solidarity and generosity towards Venezuelan migrants. Most of them maintained an open border policy and some even
